1 PRELIMINARY TEXT 2 THE PRELIMINARY TEXT OF THE PROPOSED RULE IS: 3 64-4.201 Renewal Application Requirements for MMTCs 4 5 (1) Each licensed MMTC seeking renewal of its MMTC license shall submit a renewal application to the 6 department using Form DHXXX-OMMU-XX/2021 "Medical Marijuana Treatment Center Application Instructions 7 Manual for License Renewal," herein incorporated by reference and available 8 https://www.flrules.org/Gateway/reference.asp?No=Ref-XXXXX together with a renewal fee of \$60,063.00. 9 (2) Renewal applicants may not submit variance requests, pursuant to Rule 64-4.023, F.A.C., as part of the 10 renewal application. 11 (3) The following are grounds for denial of a renewal application: 12 (a) Failure to submit the \$60,063 renewal fee; 13 (b) Failure to provide documentation required by the "Application and Instructions for MMTC License Renewal"; 14 (c) Failure to timely correct errors or omissions or supply required information to the department upon request 15 made pursuant to s. 120.60, F.S.; 16 (d) Failure to meet minimum statutory requirements; and 17 (e) Any deficiencies or violations that are grounds for revocation or denial pursuant to statute or department rule. 18 (4) All other MMTCs shall submit an "Medical Marijuana Treatment Center Application Instructions Manual for 19 License Renewal," biennially, which must be received by the department at least 30 days, but not more than 60 days, 20 before the license expires. 21 (5) An MMTC's "Medical Marijuana Treatment Center Application Instructions Manual for License Renewal," 22 renewal fee, and supporting documentation, must be delivered to the department's Agency Clerk, at the address 23 provided in the "Application and Instructions for MMTC License Renewal," no later than 5:00 p.m. EST on the 24 deadline established in section (4). If the deadline falls on a Saturday, Sunday, or legal holiday, then the deadline 25 shall fall on the next day which is not a Saturday, Sunday, or legal holiday. 26 (6) Renewal applications that are not received by the department's Agency Clerk, at the address provided in the 27 "Application and Instructions for MMTC License Renewal" on or before the date and time set forth in this rule, will 28 not be considered.

29	(7) Prior to December 31, 2026, the department shall review this rule and amend, modify or repeal the rule if it is
30	determined to create barriers to entry for private business competition, is duplicative, outdated, obsolete, overly
31	burdensome, or imposes excessive costs. In the event the department fails to complete this rule review, the department
32	shall begin the rule repeal process in accordance with chapter 120, F.S.
